

Brennen Elementary School Chorus Chorus Expectations Contract

- Chorus members are expected to follow music room rules during rehearsal time. Any discipline problems will result in automatic dismissal from the chorus (this includes excessive talking during rehearsal).
- Chorus members are expected to attend rehearsals. Any absences from rehearsals must have a written excuse turned into Mr. Lindley. **TWO UNEXCUSED ABSENCES will result in automatic dismissal from the chorus.**
 - **Rehearsals will be held on Wednesdays from 2:35-3:30**
- Chorus parents are expected to pick up their students no later than 3:40 pm every Wednesday. Parents are to remain outside or in the side car pick-up line during chorus dismissal. **TWO LATE PICK-UPS** may result in automatic dismissal from the chorus. A pick-up that is over 30 minutes late may result in automatic dismissal from the chorus. Late pick-ups that exceed 45 minutes may result in law enforcement notification.
- Chorus members are expected to attend and participate in ALL performances. Any performance absence must have a written excuse turned into Mr. Lindley one week prior to the performance. Students with an unexcused absence for performances will be dismissed from the chorus.
- Students are expected to arrive to performances at call time. Students that do not arrive to performances by call time specified by Mr. Lindley will not be allowed to perform.
- Students are expected to wear a chorus uniform during performances. Students must purchase a chorus polo shirt for \$15 or request to use a school-owned shirt. The student will be expected to wear black pants or skirt (no shorts or capris). Skirts must be knee length or longer. Students are expected to wear DARK shoes. No tennis shoes, please.
- Chorus members must pay a \$25 nonrefundable student activity fee to join chorus. This fee is in place to supply music, cover field trip expenses, and other chorus costs.
- By signing this contract, you are allowing pictures of your student to be posted on Brennen Chorus social media (Facebook, Twitter, Instagram, and school website).
- Chorus Expectations Contract must be read over by student and parent. The **COMPLETED** contract must be turned into Mr. Lindley no later than Wednesday, September 6. Incomplete contracts will be returned to the student. Students will not be allowed to attend rehearsal without a completed contract. Rehearsals will begin on Wednesday, September 6.
